We believe at Cavendish Close Infant School that a high-quality Art and Design education should provide all pupils with the opportunity to engage, inspire and challenge, giving children the knowledge and skills to experiment, invent and create their own works of art.

We have a duty to ensure compliance with the revised National Curriculum and with the application of the new programmes of study and attainment targets.

**Aims**

- To produce creative work, exploring their ideas and recording their experiences.
- To become proficient in drawing and painting, sculpture and other art, craft and design techniques.
- To evaluate and analyse creative works using the language of art, craft and design.
- To know about great artists, craft makers and designers, and understand the historical and cultural development of their art forms.

**Roles and Responsibility for the Policy**

**Role of the Subject Leader**

The Subject Leader will:

- lead the development of this policy throughout the school;
- work closely with the Headteacher, the nominated governor and SENCO;
- be accountable for standards in this subject area;
- monitor standards by;
  - auditing the subject area
  - review of the scheme of work
  - monitoring teachers planning
  - lesson observations
  - scrutinising children's work
  - discussions with pupils
- ensure continuity and progression throughout the school;
- devise a subject improvement plan;
- provide guidance and support to all staff;
- provide training for all staff when the need arises;
- attend appropriate and relevant INSET;
- keep up to date with new developments;
- undertake an annual audit and stock take of resources;
- purchase new resources when required;
- manage the subject budget effectively;

- undertake risk assessments when required;
- review and monitor;
- annually report to the Governing Body on the success and development of this policy

### **Role of Teachers**

Teachers will:

- comply with all aspects of this policy;
- work closely with the subject leader to develop this policy;
- devise medium and short term planning;
- develop mathematical fluency, numeracy and mathematical understanding in Art and Design;
- develop pupils' spoken language, reading, writing and vocabulary in Art and Design;
- plan and deliver good to outstanding lessons;
- plan differentiated lessons which are interactive, engaging and of a good pace;
- have high expectations for all children and will provide work that will extend them;
- assess, record and report on the development, progress and attainment of pupils;
- achieve high standards;
- celebrate the success of pupils in lessons

### **Policy Procedure**

#### **Teaching and Learning Style**

We use a variety of teaching and learning styles in order to develop children's knowledge, skills and understanding.

#### **Curriculum Planning and Organisation**

Teachers collaborate on the planning of the subject to ensure consistent provision and to share expertise. Curriculum planning is managed in three phases namely:

##### **Long Term Planning-Curriculum Overview**

- details what is to be taught over the year
- provides teaching guidelines and overall objectives for each year group for the whole year

##### **Medium Term Planning**

- organises the subject into termly or half-termly sections
- is more detailed and the objectives are more specific in nature
- is developed by the teachers, who respond to the needs of their pupils
- ensures a balanced distribution of work is undertaken across each term

##### **Short Term Planning**

- details the subject curriculum over the week

- plans lessons in detail with specific class objectives and subject specific vocabulary

### **Links with ICT**

The use of information and communication technology will promote, enhance and support the teaching of art and design.

### **Inclusion**

We believe that we are an educationally inclusive school as we are concerned about the teaching and learning, achievements, attitudes and well-being of all our pupils.

We work hard to offer equality of opportunity and diversity to all groups of pupils within school such as children:

- from both sexes;

We want to give all children the right to access high quality educational experiences, to take part in a broad and balanced curriculum and to be part of the social life of the school.

### **Differentiation**

We want all children to achieve success, therefore we will ensure they are given differentiated tasks that are matched to their level of attainment so that they can demonstrate successfully what they know, understand and can do.

### **Special Educational Needs**

We aim to ensure that pupils with identified special educational needs have full access to art and design lessons. Teachers plan lessons that have no barriers to pupils achieving and set appropriate targets.

## **Assessment for Learning**

Teachers will:

- carry out continuous assessment;
- use short-term assessments matched to the teaching objectives to adjust their planning;
- carry out medium-term assessments to measure progress against key objectives to adjust planning;
- carry out long-term assessment to assess progress against school and national targets;
- use long-term assessments to help them plan for the next academic year;
- inform parents and carers of their child's progress and targets

## **Monitoring & Review of the Subject**

Monitoring of standards of children's work and the quality of teaching is the responsibility of the subject coordinator supported by the Headteacher and the SLT.

Standards will be monitored by:

- looking at pupils work
- subject observations
- pupil discussions and interviews
- scrutiny of planning
- general curriculum discussions

## **Contribution of the Subject to other Areas of the Curriculum**

Art and design can be linked to most curriculum subjects and cross curricular planning is encouraged where appropriate.

## **Resources**

The school has a full range of resources to support the teaching of art and design throughout all year groups. Resources are upgraded and replenished when the need arises. An annual stock take and audit is undertaken by the subject coordinator.

## **Monitoring the Effectiveness of the Policy**

The practical application of this policy will be reviewed annually or when the need arises by the coordinator, the Headteacher and the nominated governor.

A statement of the policy's effectiveness and the necessary recommendations for improvement will be presented to the Governing Body for further discussion and endorsement. (See Policy Evaluation)
