Coming into School	Site Staff	COVID – 19	<ul> <li>Site staff to ensure they are fit and well to carry out maintenance tasks at school.</li> <li>Any sign of feeling unwell i.e. cough, fever they must self - isolate and inform their Head Teacher immediately.</li> </ul>	Low	Y	
Use of face shields / masks	Site Staff	Infection Control	<ul> <li>Site staff to wear face shields / masks when in the building carrying out their duties. This decision is based upon Site staff having access to all areas of the school. Updated 22/09/20.</li> <li>Site staff to wear face shields / masks on external school site at the start and end of the day – when children are received from and dismissed to parents/other adults. Parents have also been asked to wear face masks/coverings. Updated 22/09/20.</li> <li>When face coverings are worn, they must be removed correctly without touching the front of the mask. Hands are to be washed / sanitised thoroughly following removal.</li> <li>If disposable face masks are worn, they must be disposed of in a closed bin.</li> <li>If material re-usable face masks are worn, they should be placed inside a disposable bag and taken home to re-wash before reusing.</li> </ul>	MED	~	



			If face shields are worn they must be cleaned thoroughly on both sides after each use with antibacterial wipes / spray.		
Carrying out maintenance tasks	Site Staff	COVID – 19	<ul> <li>All tasks which may be carried out by Site Staff must be low risk if working alone.</li> <li>Wash hands on a regular basis with warm soapy water or if not available with an alcoholic hand sanitiser (at least 60%).</li> <li>Wear gloves if possible and when removing take off by removing inside out. Dispose in a bin (with a bin liner inside) wash hands with warm soapy water or if not available with an alcoholic hand sanitiser (at least 60%).</li> <li>Hard surfaces to be cleaned with a mild disinfectant.</li> </ul>	Low	Y

Security	Site Staff	Incidents	Site Manager to ensure they keep the school secure at all times when working on own.	Low	Y
Statutory Tests and Inspections	Staff Pupils Others	Maintenance issues	<ul> <li>All statutory testing and inspecting to continue as previously prior to COVID 19.</li> <li>In-house inspections should continue to ensure the school remains as safe as possible whilst open.</li> </ul>	Low	Y
