			<ul style="list-style-type: none"> <li>➤ Toilet flushes and regular cleaning of toilets.</li> <li>• All classrooms to have spray disinfectant and where possible disposable cloths. If disposable cloths are not available use once and then put in wash. Cloths must not be shared.</li> <li>• Regular cleaning of surfaces will reduce the risk of spreading the virus.</li> <li>• All used reusable cloths stored in classroom in a sealed box, before boil washing.</li> </ul>			
Ventilation class/office	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Identify any poorly ventilated spaces and take steps to improve fresh air flow</li> <li>• If mechanical ventilation systems are used to draw fresh air or extract air from a room these should be adjusted to increase the ventilation rate wherever possible</li> <li>• Ensure that mechanical ventilation systems only circulate fresh outside air and where this is not possible, in a single room supplement with an outdoor air supply</li> <li>• Where appropriate open external windows, internal doors and external doors to improve natural ventilation</li> <li>• If external doors are opened, ensure that they are not fire doors and are safe to do so</li> </ul>	MED		✓
Poor hygiene practice	Staff Pupils Others	Ill Health	<ul style="list-style-type: none"> <li>• You should continue to ensure that children clean their hands regularly, this can be done with soap and water or hand sanitiser</li> <li>• Staff and visitors are encouraged to wash their hands with soap or alcohol-based sanitiser (that contains no less than 60% alcohol) and follow infection control procedures in accordance with the DfE and PHE's guidance.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• Sufficient amounts of soap (or hand sanitiser where applicable), clean water and paper towels are supplied in all toilets and kitchen areas.</li> <li>• Pupils are supervised by staff when washing their hands to ensure it is done correctly, where necessary.</li> <li>• Pupils are discouraged from sharing cutlery, cups or food.</li> <li>• All cutlery and cups are thoroughly cleaned before and after use.</li> <li>• Cleaners to carry out daily, thorough cleaning that follows national guidance and is compliant with the COSHH Policy and the Health and Safety Policy.</li> <li>• School Business Manager arranges enhanced cleaning to be undertaken where required – advice about enhanced cleaning protocols is sought from the HPT/PHE</li> </ul>			
Spread of infection	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>• Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times.</li> <li>• Parents are informed not to bring their children to school or on the school premises if they show signs of being unwell and believe they have been exposed to coronavirus.</li> <li>• Staff and pupils do not return to school before the minimum recommended exclusion period (or the 'self-isolation' period) has passed, in line with national guidance.</li> <li>• Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching, e.g. swimming pools.</li> </ul>	MED		✓

Ill Health	Staff Pupils Others	Coronavirus Symptoms	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an</li> </ul>	MED		✓

			<p>area where they will not come into contact with others and are supervised at all times.</p> <ul style="list-style-type: none"><li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li><li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li><li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li><li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li><li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li><li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li><li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li><li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li></ul>

<p>Poor management of infectious diseases</p>	<p>Staff Pupils Others</p>	<p>Lack of infection control</p>	<ul style="list-style-type: none"> <li>• Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>• Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible. .</li> <li>• The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.</li> <li>• The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.</li> <li>• Staff inform the headteacher when they plan to return to work after having coronavirus.</li> <li>• School Business Manager and Site Manager monitor the cleaning standards of school cleaning team and discusses any additional measures required with regards to managing the spread of coronavirus.</li> </ul> <p><a href="https://www.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/84211/contingency-framework-education-and-childcare-settings.pdf">Contingency framework: education and childcare settings (publishing.service.gov.uk)</a></p> <p><b>The thresholds, detailed below, can be used by settings as an indication for when to seek public health advice if they are concerned.</b></p> <p>For most education and childcare settings, whichever of these thresholds is reached first:</p> <ul style="list-style-type: none"> <li>➤ 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or</li> </ul>	<p>MED</p>		<p>✓</p>

			<ul style="list-style-type: none"> <li>➤ 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period</li> <li>• For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time:</li> <li>• All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered public health support in managing risk assessments and communicating with staff and parents.</li> <li>• Settings may wish to seek additional public health advice if they are concerned about transmission in the setting.</li> </ul>			
Lack of communication	Staff Pupils Others	Unsafe Practices	<ul style="list-style-type: none"> <li>• The school staff reports immediately to the headteacher about any cases of suspected coronavirus, even if they are unsure.</li> <li>• The headteacher contacts the local HPT or follows the advice given from and discusses if any further action needs to be taken.</li> <li>• Schools put into place any actions or precautions advised by their local HPT.</li> <li>• Schools keep staff and parents adequately updated about any changes to infection control procedures as necessary.</li> </ul>	MED		✓
Asymptomatic testing	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Over the summer, staff should continue to test regularly if they are attending settings that remain open.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• Regular testing will then pause in settings over the summer if they are closed.</li> <li>• However, testing will still be widely available over the summer and kits can be collected either from your local pharmacy or ordered online.</li> <li>• Early years staff should undertake twice weekly home tests whenever they are on site until the end of September, when this will also be reviewed.</li> <li>• Early years children are not included in the rapid testing programme.</li> <li>• PHE has advised there are limited public health benefits attached to testing early years children with rapid lateral flow tests.</li> <li>• Young children may find the rapid lateral flow testing process unpleasant and are unable to self-swab</li> </ul>			
Positive Cases	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• School no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>• School will support NHS Test and Trace when required to help identify close contacts</li> <li>• Children <b>under the age of 18 years old and 6 months are no longer required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case.</li> <li>• Instead they will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>• We would encourage all individuals to take a PCR test if advised to do so.</li> <li>• Children who are aged under 5 years old who are identified as close contacts will only be advised to take</li> </ul>	MED		✓

			<p>a PCR test if the positive case is in their own household.</p> <ul style="list-style-type: none"> <li>• Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of public health might advise a setting to temporarily reintroduce some control measures.</li> <li>• Staff and children with a positive rapid lateral flow test result should self-isolate in line with the guidance for households with possible coronavirus infection. They will also need to get a free PCR test to check if they have COVID-19.</li> <li>• Whilst awaiting the PCR result, the individual should continue to self-isolate.</li> <li>• If the PCR test is taken within 2 days of the positive rapid lateral flow test, <b>and is negative</b>, it overrides the rapid lateral flow test and they can <b>return to the setting</b>, as long as the individual doesn't have COVID-19 symptoms.</li> </ul>

Report as <b>soon</b> as you are able to, and in any case within <b>14 days</b>.</li> </ul>	MED		✓

			<p>the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</p> <ul style="list-style-type: none"> <li>Your decision would need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>

Staff CEV	Staff	Infection control	<ul style="list-style-type: none"> <li>CEV people are <b>no longer advised</b> to shield but may wish to take extra precautions to protect themselves and to follow the practical steps set out in the CEV guidance to minimise their risk of exposure to the virus</li> <li>Staff should attend their place of work if they cannot work from home</li> <li>The school will follow DHSC updated guidance</li> </ul>	MED		✓

<p>Transport and face coverings</p>			<ul style="list-style-type: none"> <li>• Full risk assessments must be undertaken.</li> <li>• It is recommended that facemasks are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. This includes public transport.</li> <li>• It is important to ensure vehicles are well ventilated when occupied, by opening windows. The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> <li>• Children, young people and adults should follow <b>public health advice</b> on when to self-isolate and what to do.</li> <li>• They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li> <li>• If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li> <li>• They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li> <li>• Schools should have contingency plans outlining how they would operate if the number of positive cases substantially increases in the school or local area. 			<ul style="list-style-type: none"> <li>• Individuals are not required to self-isolate if they are a close contact of someone with COVID-19 if they are fully vaccinated, below the age of 18 years and 6 months, taking part in an approved COVID-19 vaccine trial or are unable to get vaccinated for medical reasons. Instead they will be advised to take a PCR test. They will not need to wear a face covering within the setting.</li> <li>• Check with the provider that they are following the relevant guidance to reduce the risk of infection</li> <li>• If the number of positive cases substantially increases, please refer to the Outbreak Management Plan.</li> </ul>
