Use of Transport	Staff Pupils Others	Infection Control	<ul style="list-style-type: none"> <li>• It is recommended that facemasks are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. This includes public transport.</li> <li>• It is important to ensure vehicles are well ventilated when occupied, by opening windows. The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> <li>• Children, young people and adults should follow <u>public health advice</u> on when to self-isolate and what to do.</li> <li>• They should not board dedicated transport or public transport if they have symptoms or other reasons</li> </ul>	MED		✓

Ventilation class/office	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Identify any poorly ventilated spaces and take steps to improve fresh air flow</li> <li>• If mechanical ventilation systems are used to draw fresh air or extract air from a room these should be adjusted to increase the ventilation rate wherever possible</li> <li>• Ensure that mechanical ventilation systems only circulate fresh outside air and where this is not possible, in a single room supplement with an outdoor air supply</li> <li>• Where appropriate open external windows, internal doors and external doors to improve natural ventilation</li> <li>• If external doors are opened, ensure that they are not fire doors and are safe to do so</li> </ul>	MED		✓
Poor hygiene practice	Staff Pupils Others	Ill Health	<ul style="list-style-type: none"> <li>• You should continue to ensure that children clean their hands regularly, this can be done with soap and water or hand sanitiser</li> <li>• Staff and visitors are encouraged to wash their hands with soap or alcohol-based sanitiser (that contains no less than 60% alcohol) and follow infection control procedures in accordance with the DfE and PHE's guidance.</li> <li>• Sufficient amounts of soap (or hand sanitiser where applicable), clean water and paper towels are supplied in all toilets and kitchen areas.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• Pupils are supervised by staff when washing their hands to ensure it is done correctly, where necessary.</li> <li>• Pupils are discouraged from sharing cutlery, cups or food.</li> <li>• All cutlery and cups are thoroughly cleaned before and after use.</li> <li>• Cleaners to carry out daily, thorough cleaning that follows national guidance and is compliant with the COSHH Policy and the Health and Safety Policy.</li> <li>• School Business Manager arranges enhanced cleaning to be undertaken where required – advice about enhanced cleaning protocols is sought from the HPT/PHE</li> </ul>			
Spread of infection	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>• Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times.</li> <li>• Parents are informed not to bring their children to school or on the school premises if they show signs of being unwell and believe they have been exposed to coronavirus.</li> <li>• Staff and pupils do not return to school before the minimum recommended exclusion period (or the 'self-isolation' period) has passed, in line with national guidance.</li> <li>• Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching.</li> <li>• Parents notify the school if their child has an impaired immune system or a medical condition that means they are vulnerable to infections.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• The school in liaison with individuals' medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections.</li> <li>• Any additional provisions for pupils who are vulnerable to infections are put in place by the headteacher, in liaison with the pupil's parents where necessary.</li> </ul>

Personal Protective Equipment Face Coverings	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Face coverings can be worn in corridors or communal areas – Personal choice</li> <li>• It is recommended that they are worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet. Ill Health	Staff Pupils Others	Coronavirus Symptoms	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> </ul>			
Asymptomatic testing Summer School	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Schools will only provide tests for twice weekly asymptomatic testing for staff over the summer period if they are attending school settings.</li> </ul>	MED		✓

<b>Primary School Pupils</b> Autumn Term Asymptomatic testing	Staff	Infection Control	<ul style="list-style-type: none"> <li>There is no need for primary age pupils (those in year 6 and below) to test over the summer period.</li> <li>No testing is required of Primary age children</li> <li>Staff should undertake twice weekly home tests whenever they are on site until the end of September when this will be reviewed</li> </ul>	MED		✓
Positive Cases	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>School no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>School will support NHS Test and Trace when required to help identify close contacts</li> </ul> <p><b>From 16<sup>th</sup> August 2021</b></p> <ul style="list-style-type: none"> <li>From 16 August 2021, children <b>under the age of 18 years old will no longer be required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case.</li> <li>Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>We would encourage all individuals to take a PCR test if advised to do so.</li> </ul> <p><b>Over 18 years of age</b></p> <ul style="list-style-type: none"> <li>18-year-olds will be treated in the same way as children <b>until 6 months after their 18th birthday</b>, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of public health might advise a setting to temporarily reintroduce some control measures.</li> </ul> <p><b>Staff / Pupils</b></p> <ul style="list-style-type: none"> <li>with a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self-test and the pupils/staff can return to school as long as the individual doesn't have COVID-19 symptoms</li> </ul>			
Poor management of infectious diseases	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible.</li> <li>The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.</li> <li>The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.</li> <li>Staff inform the headteacher when they plan to return to work after having coronavirus.</li> </ul>	MED		✓

- The Site Manager and School Business Manager will monitor the cleaning standards of school cleaning team and discusses any additional measures required with regards to managing the spread of coronavirus.

**The thresholds, detailed below, can be used by settings as an indication for when to seek public health advice if they are concerned.**

For most education and childcare settings, whichever of these thresholds is reached first:

- 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or
- 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period
- All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered public health support in managing risk assessments and communicating with staff and parents.
- Settings may wish to seek additional public health advice if they are concerned about transmission in the setting.

Admitting children into school	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>• In most cases, parents and carers will agree that a pupil with symptoms should not attend the school, given the potential risk to others. If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</li> <li>• Your decision would need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>	MED		✓
CEV children	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• All CEV children should attend their education setting unless they are one of the very small number of children under paediatric or other specialist care who have been advised by their GP or clinician not to attend</li> </ul>	MED		✓

Admitting people into school	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Pupils, staff and other adults <b>should not</b> come into school if they have symptoms, have had a positive test result or have been instructed to quarantine</li> <li>• Anyone staff or pupils within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow public health advice</li> <li>• In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised</li> <li>• If the member of staff is in close contact with the child then they should wear appropriate PPE</li> <li>• A window should be opened for fresh air ventilation if possible</li> <li>• Any rooms that have been used for this purpose should be cleaned after they have left</li> <li>• As anyone within the household should follow the PHE guidance for households with possible or confirmed COVID-19 infection, then any siblings within the school will be identified and also sent home.</li> </ul>	MED		✓
Staff CEV	Staff	Infection control	<ul style="list-style-type: none"> <li>• CEV people are <b>no longer advised</b> to shield but may wish to take extra precautions to protect themselves and to follow the practical steps set out in the CEV guidance to minimise their risk of exposure to the virus</li> <li>• Staff should attend their place of work if they cannot work from home</li> <li>• The school will follow DHSC updated guidance</li> </ul>	MED		✓

Educational visits	Pupils Staff	Financial risk	<ul style="list-style-type: none"> <li>• If booking new visits ensure that the school have adequate financial protection in place</li> <li>• Full risk assessments must be undertaken.</li> </ul>	MED		✓
Wraparound care	Pupils	Infection Control	<ul style="list-style-type: none"> <li>• Consideration should be given to the latest government advice regarding the specific activity being undertaken and venue visited</li> <li>• Pupils should be encouraged to attend settings close to where they live or go to school, ideally within walking or cycling distance</li> <li>• Where they attend venues further afield they should follow latest guidance <a href="https://www.gov.uk/guidance/coronavirus-covid-19-safer-travel-guidance-for-passengers">https://www.gov.uk/guidance/coronavirus-covid-19-safer-travel-guidance-for-passengers</a></li> <li>• Wraparound childcare providers can offer provision to all children, without restriction on the reasons for which they may attend.</li> <li>• Wraparound childcare and other organised activities for pupils may take place in groups of any number.</li> <li>• You should ensure that key contractors are aware of your setting's control measures and ways of working.</li> <li>• Ensure you have enough staff available to meet the required ratio</li> </ul>	MED		✓
Out of school settings Parents attendance	Pupils Parents Staff Others	Infection Control	<ul style="list-style-type: none"> <li>• Parents are no longer limited to specific number attendance.</li> <li>• Ensure up to date contact information is available in the event of an emergency.</li> <li>• Keep a record of where and when your child attends a setting to help NHS Test and Trace identify contacts. Out of school settings will not be expected to undertake contact tracing.</li> </ul>	MED		✓

			<ul style="list-style-type: none"><li>• Individuals are not required to self-isolate if they are a close contact of someone with COVID-19 if they are fully vaccinated, below the age of 18 years and 6 months, taking part in an approved COVID-19 vaccine trial or are unable to get vaccinated for medical reasons. Instead they will be advised to take a PCR test. They will not need to wear a face covering within the setting.</li><li>• Check with the provider that they are following the relevant guidance to reduce the risk of infection.</li><li>• If the number of positive cases substantially increases, please refer to the Outbreak Management Plan.</li></ul>
